CIRCULAR NO. 19-001 /M.

TO : All Shipping Line Companies, Accredited Port Users, Arrastre and Stevedoring Operators, CEZA Registered Enterprises, Others Concerned

SUBJECT : Revised Schedule of Cargo Handling Tariff for General Cargoes

Section 47 of CAO 001, Series of 2002 and AO 001 s2010, which provides for Cargo Handling Tariff, is hereby amended to adopt PPA Memorandum Circular No. 2-2018 for General Cargoes which read as follows:

“Section 47. Cargo Handling Tariff. Accredited cargo handling operator shall follow the prescribed CEZA Cargo Handling Tariff as prescribed below:


