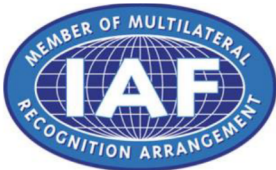

CEZA CONTINUES TO HOLD ITS ISO 9001:2015 QUALITY MANAGEMENT SYSTEM CERTIFICATION



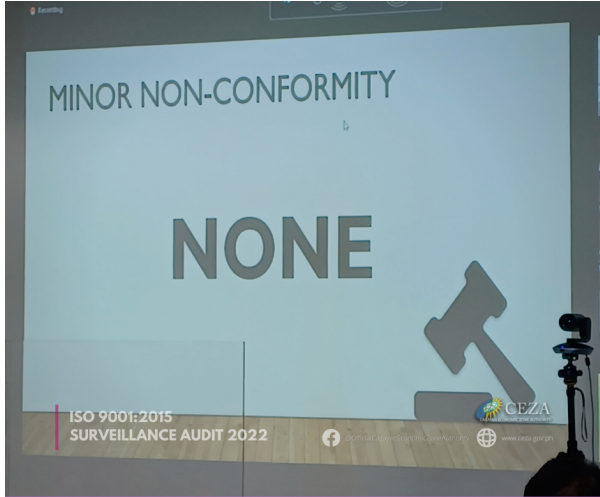
